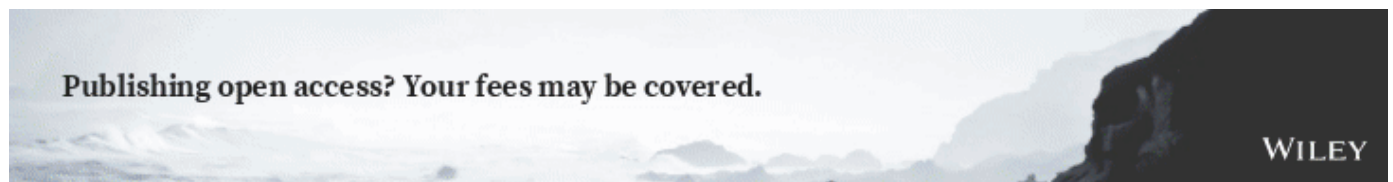

Journal of Internal Medicine now offers [Free Format submission](#) for a simplified and streamlined submission process.

Before you submit, you will need:

- Your manuscript: this should be an editable file including text, figures, and tables, or separate files—whichever you prefer. All required sections should be contained in your manuscript, including abstract, introduction, methods, results, and conclusions. Figures and tables should have legends. Figures should be uploaded in the highest resolution possible. If the figures are not of sufficiently high quality your manuscript may be delayed. References may be

submitted in any style or format, as long as it is consistent throughout the manuscript. Supporting information should be submitted in separate files. If the manuscript, figures or tables are difficult for you to read, they will also be difficult for the editors and reviewers, and the editorial office will send it back to you for revision. Your manuscript may also be sent back to you for revision if the quality of English language is poor.

- An ORCID ID, freely available at <https://orcid.org>. (*Why is this important? Your article, if accepted and published, will be attached to your ORCID profile. Institutions and funders are increasingly requiring authors to have ORCID IDs.*)
- The title page of the manuscript, including:
- Your co-author details, including affiliation and email address. (*Why is this important? We need to keep all co-authors informed of the outcome of the peer review process.*)
- Statements relating to our ethics and integrity policies, which may include any of the following (*Why are these important? We need to uphold rigorous ethical standards for the research we consider for publication*):
 - data availability statement
 - funding statement
 - conflict of interest disclosure
 - ethics approval statement
 - patient consent statement
 - permission to reproduce material from other sources
 - clinical trial registration

- *Role of the corresponding author*

The corresponding author will serve on behalf of all co-authors as the primary correspondent with the editorial office during the submission and review process. When submitting a manuscript to JIM, the corresponding author will, on behalf of all co-authors, be required to declare that:

(i) the manuscript has not been published, is not under consideration for publication elsewhere, and will not be republished in any other journal in the same or similar form without the written consent of the editor of JIM and Wiley Ltd;

(ii) authorship is based on four criteria specified by the International Committee of Medical Journal Editors ICMJE Authorship (see below: Authorship criteria and contributions);

(iii) written permission has been obtained from all individuals listed in the Acknowledgements;

(iv) they have had full access to all of the data in the study and take complete responsibility for the integrity and the accuracy of the data analysis;

(v) all authors have completed the ICMJE Form for Disclosure of Potential Conflicts of Interest, and the manuscript includes a 'Conflict of interest statement.' A lack of conflicts of interest must also be declared.

Please note: The corresponding author must collect the ICMJE forms from all authors and summarize their declarations within the manuscript. Copies of the forms do not need to be sent to JIM, but the forms must be made available by the corresponding author on request.

When an accepted article is received by Wiley's production team, the corresponding author will receive an email asking them to log in. They will be asked to sign a publication license at this point and pay for any applicable APCs.

- *ORCID iD*

JIM requires that submitting and corresponding authors register for an ORCID iD and provide the details at submission. The ORCID information should include employment, education and work history.

If you limit the visibility settings on your ORCID account, make JIM a "trusted organization." An ORCID page that contains no information visible to the Editorial Office does not satisfy JIM requirements. To learn more about ORCID, please visit orcid.org/content/initiative

- *Conflicts of interest and financial disclosure*

All authors must complete the **ICMJE Form for Disclosure of Potential Conflicts of Interest** and send the completed forms to the corresponding author. A statement of financial or other relationships that might lead to a conflict of interest must be declared. It should also be stated if authors have no conflicts of interest to declare.

- *Authorship criteria and contributions*

For all articles, the journal mandates the CRediT (Contribution Roles Taxonomy). For more information, please see **Wiley Author Services**.

Authorship credit is based on the four criteria specified by the ICMJE as revised in 2013:

(i) substantial contributions to the conception or design of the work, or the acquisition, analysis, or interpretation of the data for the work;

(ii) drafting of the work or revising it critically for important intellectual content;

(iii) final approval of the version to be published;

(iv) agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved (ICMJE/recommendations).

- *Acknowledgements*

All contributors who do not meet the criteria for authorship should be listed in the Acknowledgements. Authors must obtain written permission to include the names of all individuals included in the Acknowledgements, and the corresponding author must confirm that such permission has been obtained.

For articles with collaborators in a consortium or study group, the group name must be included in the author byline. The individual names of group members can be listed in the Acknowledgements or as supplemental information, with written permission obtained for each name listed. The individual names will then be indexed in PubMed as collaborators.

- *Disclosing the use of artificial intelligence (AI)*

If you or your co-authors have used Artificial Intelligence Generated Content (AIGC) tools such as ChatGPT and others based on large language models (LLMs) to develop any portion of a manuscript, their use must be described transparently and in detail in the Methods section. Find more details in Wiley's AI policy in full in the **Best Practices Guidelines on Research Integrity and Publishing Ethics**.

- *Data sharing and data availability*

JIM encourages data sharing. Review **Wiley's Data Sharing Policy** where you will be able to see

and select the data availability statement that is right for your submission. JIM authors should include a data availability statement, including a link to the public repository used and a persistent identifier (e.g., a DOI for the data, or an accession number) from the repository. The statement will be published alongside the paper.

- *Reproduction of copyright material*

If excerpts from copyrighted works owned by third parties are included, credit must be shown in the contribution. It is the corresponding author's responsibility to also obtain written permission for reproduction from the copyright owners and to supply Wiley with that permission upon submission. For more information visit [Wiley's Copyright Terms & Conditions FAQ](#).

- *Preprint policy*

JIM will consider for review articles previously available as preprints. Authors may also post the submitted version of a manuscript to a preprint server at any time. Any previous publication as a preprint should be disclosed in the paper in Acknowledgements. Authors are requested to update any pre-publication versions with a link to the final published article.

- *Clinical trials*

The ICMJE defines a clinical trial as any research project that prospectively assigns human participants to intervention or comparison groups to study the cause-effect relationship between an intervention and a health outcome ([ICMJE/recommendations](#)). Interventions include but are not limited to drugs, surgical procedures, devices, behavioral treatments, and changes in the process of care. All manuscripts reporting clinical trials must include a copy of the trial protocol with the complete statistical analysis plan, a flow diagram and a completed trial checklist. All clinical trials must be registered at an appropriate online public registry.

- *Guidelines on publishing and research ethics in journal articles*

JIM requires that authors include in the manuscript details IRB approvals and, a statement regarding the ethical treatment of human and animal research participants, and the gathering of informed consent, as appropriate. Authors will be expected to declare all conflicts of interest, or none, on submission. Please review Wiley's policies surrounding [human studies](#), [animal studies](#), [clinical trial registration](#), [biosecurity](#), and [research reporting guidelines](#).

JIM follows the core practices of the [Committee on Publication Ethics \(COPE\)](#) and handles cases of research and publication misconduct accordingly.

JIM uses iThenticate's Crossref software to detect instances of overlapping and similar text in submitted manuscripts. Read [Wiley's Top 10 Publishing Ethics Tips for Authors](#) and [Wiley's Publication Ethics Guidelines](#).

JIM participates in an image integrity program. Images that you submit should be original and are subject to an integrity check.

- *Plagiarism and misconduct*

JIM is a member of [COPE \(Committee of Publication Ethics\)](#) and strictly adheres to its [Code of Conduct for Journal Editors](#). This means that if the editors suspect research misconduct, the article in question will be held in abeyance until the matter is resolved. The editors will contact the authors and any appropriate third party to ascertain whether the grounds for investigation are justified.

If a research paper that has been published in JIM is found to be fraudulent, it will be retracted and appropriate steps will be taken to notify both journal readers and the authors' institution(s). Retractions will include the word 'Retraction' in the title, so that they are identified as such on

indexing systems, such as PubMed. In the case of serious research misconduct, all authors may be banned from future publication in JIM. All manuscripts accepted for publication in JIM are screened for plagiarism against previously published work using [Crossref](#).

- *Copyright & licensing*

Authors may choose to publish under the terms of the journal's standard copyright agreement, or Open Access under the terms of a Creative Commons License. Standard [re-use and licensing rights](#) vary by journal. Note that [certain funders](#) mandate a particular type of CC license be used. JIM uses the CC-BY/CC-BY-NC/CC-BY-NC-ND [Creative Commons License](#).

Self-archiving definitions and policies: Note that the journal's standard copyright agreement allows for [self-archiving](#) of different versions of the article under specific conditions.

- *Coalition S funding*

Authors should ensure they are familiar with any funder or institutional mandates for publishing their paper. Articles can be published as Open Access under a CC-BY license in the Journal of Internal Medicine but if a funder is a member of Coalition S, then the article is to be published in a fully Open Access journal according to Plan S.

An exception would be if an author's institution is part of one of Wiley's transformative agreements. In these cases, authors would still be compliant with Plan S when publishing in the Journal of Internal Medicine. Information about licensing options is available [here](#). The submitting author is expected to consult all authors to find out whether any of their funders has a policy that restricts which kinds of license they can sign.

- *Funding*

Funding information is entered at manuscript submission and will appear alongside the published article. Therefore, it is not necessary to include funding information in the manuscript itself unless there is reason to do so, such as to provide additional information regarding funding. If included in the manuscript, please list funding sources under Acknowledgements. Authors are responsible for the accuracy of their funder designation. If in doubt, please check the [Open Funder Registry](#) for the correct nomenclature.

- *Article preparation support*

[Wiley Editing Services](#) offers expert help with English language editing before submission, as well as translation, manuscript formatting, figure illustration, and figure formatting. Authors can also consult Wiley's resources for [preparing your article](#) for general guidance about writing and preparing their manuscript.

Editorial review and publication

- *Editorial and peer review*

Manuscripts are examined by the editors of JIM and are usually sent to outside reviewers. The author should suggest at least five reviewers.

- *Refer and Transfer Program*

Wiley believes that no valuable research should go unshared. This journal participates in Wiley's Refer & Transfer program. If your manuscript is not accepted, you may receive a recommendation to transfer your manuscript to another suitable Wiley journal, either through a referral from the journal's editor or through our Transfer Desk Assistant.

- *Free Access*
Freely available to all readers on Wiley Online Library, including those who do not subscribe to the journal. Please note that all Reviews and articles accompanied by an Editorial are Free Access on Wiley Online Library for JIM. The Editor-in-Chief may also select some Original Articles for Free Access. Please note that if a CC-BY license is required for a paper, the option for Open Access will need to be selected after acceptance and this option will incur a charge.
- *Open Access*
JIM is a subscription journal offering an Open Access option. Authors will have the option to choose to make an article Open Access after acceptance, which will be subject to an Article Publication Charge (APC), unless a waiver applies. To read more about Article Publication Charges, please visit the [Open Access page](#). With Open Access, the author, the author's funding agency, or the author's institution pays a fee of USD 4,780 to ensure that the article is made available to non-subscribers upon publication via Wiley Online Library, as well as deposited in the funding agency's preferred archive. Prior to acceptance, there is no requirement to inform the editorial office of the intent to publish the article as Open Access. All Open Access articles go through the standard peer-review evaluation process.
- *Online production tracking through Wiley Author Services*
This service enables authors to track their article once it has been accepted for publication, through the production process to publication online and in print. Authors can check the status of their articles online and choose to receive automated emails at key stages of the production process. Authors will receive an email providing a unique link enabling them to register so that their article can be automatically added to the system. Therefore, a correct email address must be provided when submitting a manuscript. [Wiley Author Services](#) provides more details on online production tracking, as well as FAQs and tips on article preparation and submission.
- *Early View*
Early View articles are published online after they have undergone typesetting and proof correction and can be placed in an issue.
- *Proofs*
Authors will receive an email notification with a link and instructions for accessing HTML page proofs online with their proofs included as a PDF. Authors should make sure that any renumbered tables, figures, or references match text citations and that figure legends correspond with text citations and actual figures. Proofs should be returned within 48 hours of receipt of the email.
- *Offprints*
Upon online publication, JIM allows free access to the PDF file of the final published article. To obtain access, authors must register at Wiley Author Services. Of note, free access to the final PDF offprint or the article will only be available to authors via the Author Services website. Therefore, authors are encouraged to sign up for Wiley Author Services to access their article PDF offprint and the other benefits the service offers.
- *Author material archive policy*
Unless specifically requested, Wiley will dispose of all hardcopy or digital material submitted two months after publication. If authors require the return of any material submitted, please inform the editorial office or production editor as soon as possible.

Article type

Submitted articles are initially reviewed by at least two editors. Those judged to be of possible interest are generally sent for external peer-review.

Commissioned articles such as Editorials, Reviews and Perspectives are usually assessed in-house, but external peer review is sometimes undertaken.

- *Review Article*
Reviews are usually commissioned, but unsolicited manuscripts may be welcome. Reviews should include an informative abstract where relevant key findings are presented. The recommended standard length is 5000-7000 words excluding the abstract, tables, figures, references and online-only supporting information. Abstract not exceeding 250 words. 3-4 displays (tables/figures) that summarize important results are recommended.
- *Perspective*
A Perspective focuses on current research issues and visions for the future, frequently with a more subjective touch than a Review Article. The recommended standard length is 5000-7000 words excluding references. Abstract not exceeding 250 words. 3-4 displays (tables/figures).
- *Original Article*
JIM publishes Original Articles on clinical and experimental research within the broad fields of general and internal medicine. Format: Not exceeding 5000 words excluding structured abstract, tables, figures, references and online-only supporting information. Structured abstract not exceeding 250 words.
- *Brief Report*
Brief Reports are concise papers representing novel and completed work of high priority and significance. Format: Not exceeding 2000 words excluding references, 20 references, 3 displays (tables/figures). Structured abstract not exceeding 150 words. Can include online-only supporting information. Does not have Graphical Abstract.
- *Research Letter*
These Letters contain research data and are subjected to external peer-review. Format: Not exceeding 750 words, 10 references, no abstract, 1 table or figure. Can include online-only supporting information. Includes 2-6 keywords. Does not have Graphical Abstract.
- *Letter to the Editor*
Letter related to an article published in JIM.
Deadline for submission: 3 months after online publication of the JIM article. These Letters are generally sent to the authors of the article for possible comments which may be published with the Letter. Format: Not exceeding 500 words, 7 references, no abstract, no tables or figures.
- *Editorial*
Editorials are usually commissioned, but non-commissioned Editorials may also be accepted. They generally comment on an article published in the same issue, but may also raise other topics of interest to the readers. Format: Not exceeding 1500 words excluding tables, figures, references, and online-only material, 10 references, no abstract.
- *Debate*
Debates are usually commissioned and focus on topics that have attracted significant attention in recent years, but where the findings remain inconsistent, and/or the researchers hold different opinions on the current scientific evidence.

The debate will begin with an Introduction by an Editor, followed by the viewpoints of two researchers with differing opinions/interpretations. Although based on data and scientific results, the text will be written with a subjective touch.

Format: Not exceeding 750 words for each author. 1 figure or 1 table. Up to 10 References. 2-6 keywords. No Graphical Abstract.

JIM Journal of Internal Medicine rarely accepts or publishes Case Reports.

Graphical Abstract

JIM publishes graphical abstracts (GAs) for original articles, reviews, and perspectives to provide readers with a quick overview of the article's main findings or general focus. JIM encourages authors to use the GA for communicating research results, for example, in conference presentations and on social media platforms.

Authors are advised to submit a draft during the peer review process. The JIM illustrator will finalise the design before publication, at no cost.

Design guidelines

- **Tips from the illustrator:** Identify three keywords relevant to the research and find visual representations for each. Use text sparingly and consider readability. Clear communication is most important. Strive for visually appealing design choices where appropriate.
- **Template file:** Consider downloading the JIM-GA template file as a guide for placing content in relation to the title and the JIM logo. [Download here](#).
- **Image size:** 5.5x5.5 inches, Square (Final export will be used at 2000x2000 pixels)
- **File format:** Preferably any vector format that allows edits (.eps, .ai, .pdf) to help with adapting the submission to JIM's design profile before publication.
- **Avoid:** Complicated data figures, abbreviations not easily understood, cluttered design, small text or too much text, competing or distracting colour schemes, and misleading representations of the research.
- **Considerations:** Be mindful of how humans, diseases, and conditions are represented to avoid stereotypes and oversimplifications.
- **Permissions:** Authors are responsible for obtaining permission for any images used from outside sources, including published articles, professional illustrators, web pages, stock photos or image searches. Any required permissions must be submitted with the GA and mentioned in the Acknowledgements.
- **JIM's policy** is not to allow the use of business logos, organisation names, or imagery that could be viewed as advertising or that detracts from the basic science message of the GA.

Submission of manuscripts

- *Pre-submission English language editing*
Authors are encouraged to have their manuscript professionally language edited before submission, in order to (i) improve grammar, spelling and punctuation, (ii) improve clarity and resolve any ambiguity and (iii) improve word choice and ensure that the tone of the language is appropriate for an academic journal.
- *Submitting manuscripts*

New submissions should be made via the Wiley Authors submission portal <https://authors.wiley.com/journal/JOIM>. You may check the status of your submission at any time by logging on to submission.wiley.com and clicking the “My Submissions” button. For technical help with the submission system, please review our [FAQs](#) or contact submissionhelp@wiley.com.

If you cannot submit online, please contact the editorial office at info@jim.se.

All material should conform to the **ICMJE Recommendations for the Conduct, Reporting, Editing, and Publication of Scholarly work in Medical Journals**. Manuscripts can be written in either British or American English as authors prefer. Abbreviations should be kept to a minimum and an abbreviation list included, if necessary.

- *Data protection*

By submitting a manuscript to or reviewing for JIM, your name, email address, and affiliation, and other contact details the publication might require, will be used for the regular operations of the publication. Please review [Wiley's Data Protection Policy](#) to learn more.

- *Presubmission inquiry*

Authors who want the Editors' view on the suitability of a proposed manuscript, may email a presubmission inquiry to the Editorial Office at info@jim.se. Including potential topic, title and abstract is generally helpful.

- *Cover letter*

A cover letter should be included with all manuscript submissions. This is an opportunity to explain why the work is important and unique, and why it is suitable for JIM.

(i) Provide contact information for the corresponding author.

(ii) Confirm that all authors have participated in the work and approved the submission.

(iii) Verify that a conflict-of-interest statement is included.

(iv) State whether the authors have submitted any related papers from the same study.

(v) Mention if the paper is available as a preprint.

(vi) State if original research has ethical board approval.

(vii) Inform if permission has been obtained for previously published figures.

- *Arrangement of the manuscript*

The manuscript should be uploaded in a single Word file and include the following: (i) Title page, (ii) Abstract where applicable, (iii) Keywords, (iv) Main text, (v) Conflict-of-interest statement, (vi) Acknowledgments (optional), (vii) References, (viii) Figure legends, and (ix) Tables and their captions.

Title page. The first page should state the title of the paper, a running headline of not more than 40 characters (including both characters and spaces) and the names and affiliations (department, institution, city and country) of all authors.

Title. To improve searchability, the title should be informative, rather than descriptive, and clearly state the key message of the paper. A full sentence is preferred.

Abstract. For Review Articles, the abstract should provide a concise summary of the results presented and reviewed. For Original Articles and Brief Reports, the abstract should be structured with some or all of the following subheadings: Background, Objectives, Methods, Results and

Conclusion.

Keywords. List at least two, but no more than six, keywords below the abstract. The keywords given in the 'Medical Subject Headings' list in the US National Library of Medicine **MeSh** should be used when appropriate.

Ethical considerations. For studies involving ethical considerations, approval by the local ethical authority should be indicated in the Materials and methods.

Correspondence. The last page of the reference list should include the name and address, including email address, of the author to whom correspondence, including requests for offprints, should be sent. The corresponding author is advised to select an alternative proof reader from among the co-authors; the name and email address of this 'second' author should be provided.

- *References*

We recommend the use of a tool such as EndNote for reference management and formatting. Information about reference styles can be found on the **EndNote** website.

References should be numbered consecutively in the order in which they are first mentioned in the text. Authors should identify references in the text, tables and captions by Arabic numerals within square brackets: e.g. [1, 2, 4–6]. The reference form adopted by the US National Library of Medicine should be used, with titles of journals abbreviated according to the style used in Index Medicus. Only published or accepted articles should be included in the reference list. If necessary, unpublished or submitted work – including preprints – should be referred to within parentheses in the text: e.g. Jones, 2024 (unpublished data).

All authors should be listed when up to six; more than six should be abbreviated to three followed by *et al.*

- *Tables and figures*

Table and figure legends must be comprehensive so that they are understandable without reference to the text. In the full-text online edition of the article, legends may be truncated in abbreviated links to the full-screen version. Therefore, the first 100 characters of any legend should inform the reader of key aspects of the table or figure.

All tables and figures must be cited in the text.

If a previously published table, figure or illustration is used, written permission from the original publisher should be submitted with the manuscript. If the graphic is from the authors' previously published work, the original publisher should be consulted regarding the need for permissions.

Authors are encouraged to submit figures in colour, where appropriate. The journal illustrator can help authors whose articles are accepted in designing the figures. Further information on preparing high-resolution digital files can be found at [Wiley Author Services](#).

- *Participant consent for photos*
